Tender document fee of Rs. 2000/- (non-refundable) in the form of Demand Draft drawn in favour of “Mahayogi Gorakhnath KrishiVigyan Kendra, Chaukmafi, Pepeganj, payable at State Bank of India, Pepeganj, Gorakhpur” will be submitted along with Two-Bid system (A- Technical Bid and B- Financial Bid) should reach to the office of Mahayogi Gorakhnath KrishiVigyan Kendra, Chaukmafi, Pepeganj, Gorakhpur, U.P. on or before **05.10.2019 upto 5:00 p.m.**
2. 8. In case required services/work are not provided or done by the contracting agency on time, Mahayogi Gorakhnath Krishi Vigyan Kendra will be free to get the work done from any other agency from open market and the expenses on this account will be debited to the contracting agency which will be recovered from the dues/pending bills, performance security deposit etc.

9. Payment against Bill shall be made only after satisfactory services to be certified by the concerned Mahayogi Gorakhnath Krishi Vigyan Kendra officials/committee. No interest will be payable on the non-payment due to delayed submission of bills and non-satisfactory services.
